The overall aim of this research project is to investigate the interaction between corporations and other stakeholders such as government and civil society in the process of developing large-scale energy projects in Finland. More concretely, this research will examine how organizations like Nord Stream 2 AG need the approval of Finnish government and the legitimization from citizens to proceed with the pipeline project in the Finnish exclusive economic zone (EEZ). In addition, this research will study the interaction between stakeholders in the democratic country of Finland - in this case the corporate power, the government and society- to overcome wicked challenges that can be found in the energy supply and environmental issues.

Procedure and Risks:
